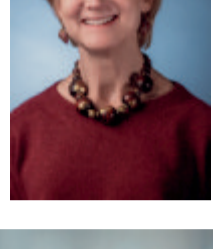

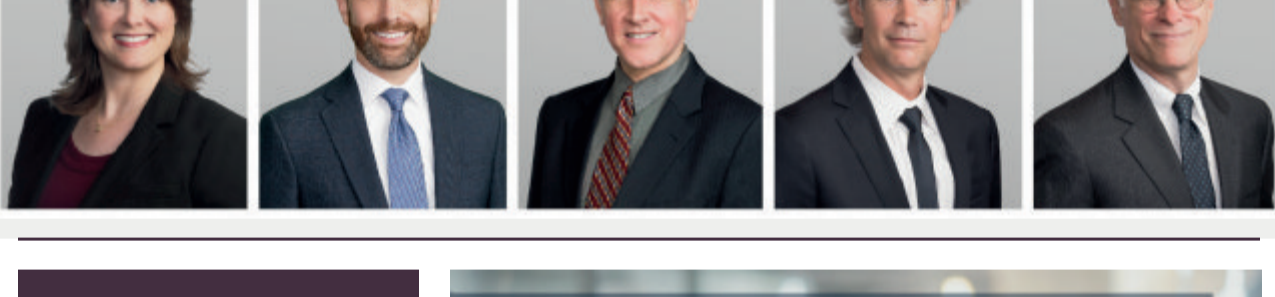

"En banc review is clearly warranted, and we believe it is essential given the significance of the panel's errors. 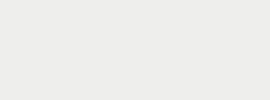
